

The committee meets regularly, twice in a year.



# Corporate Social Responsibility (CSR) Policy

## CSR Implementation

At Puravankara, we follow these two modes to implement our programs:



Partnering with third parties, including civil societies, NGOs, academic and training institutions, corporations, government entities, and community groups.



Direct implementation by Puravankara involves designing and delivering the activities ourselves.

## Monitoring Mechanism

We monitor all our projects regularly on a day-to-day basis throughout the project's life cycle. The concurrent monitoring enables us to critically evaluate the projects and make necessary course corrections whenever required. It includes:

- 01 Regular monitoring by the CSR team every month through progress reports, field visits and stakeholder interaction.
- 02 Impact assessment of the projects per law's applicability through an independent agency.
- 03 The company's CSR Committee convenes annually to approve the annual CSR plan and budget, ensure that activities align with CSR policy, and review the progress of ongoing projects.

### Audit

An external auditor will audit all CSR activities and related expenses. The company's CSR Committee will also evaluate compliance with the Companies (CSR) Policy Amendment Rules 2021.

### Communication

We regularly communicate all the information related to our social initiatives to all our stakeholders. We comply with the norms set in the Companies Act 2013 and maintain transparency in all our CSR initiatives. ## Environment

Puravankara demonstrates a strong commitment to sustainability, emphasizing environmental stewardship, community development, and economic growth. The company integrates sustainability into its core business strategies and aims to minimise carbon footprint, improve resource efficiency, and advocate for green building practices. Important initiatives, such as maintaining medians and parks, afforestation programs, and water conservation efforts, play a crucial role in fostering a sustainable future.

### Maintaining Green Spaces in Bengaluru

Puravankara has worked with Bruhat Bengaluru Mahanagar Palike (BBMP) for over a decade to maintain parks, medians, and circles, reinforcing our commitment to environmental sustainability. This partnership contributes to eco-friendly urban development, enhancing the cleanliness and greenery of Bengaluru. Through increased green spaces, we improve air quality, reduce urban heat, and create better public spaces, ultimately enhancing the quality of life for citizens and promoting a more sustainable urban environment.

#### Highlights:

- 01 Beautification and green area development activities were carried out at 7 Medians, 1 Park and 1 Circle.
- 02 Altogether, a 1,68,141 sqft green area is regularly maintained in these locations.
- 03 Approximately 400+ air-purifying, flowering, and ornamental plants are planted at these medians, parks, and circles.
- 04 With improved aesthetics and amenities (Walkways, cycling track, children's play area) for recreational activities, these areas witness increased footfall.
- 05 Regular maintenance work is undertaken to ensure a good survival rate of plants across project locations.
- 06 Approximately 4000-5000 people get benefits daily using/passing through these areas.

## Tree Plantation – Miyawaki Forest

Puravankara has adopted the Miyawaki technique for urban afforestation, which involves planting dense groves of native trees that grow rapidly and mimic the structure of natural forests. This method helps combat climate change, boosts biodiversity, and restores degraded land. In partnership with Vidyanikethan, Puravankara has initiated Miyawaki forest projects in three areas of Bengaluru, engaging local communities, government bodies, and schoolchildren. The project aims to improve environmental quality, create green spaces, and provide lasting benefits to both the community and wildlife.

### Highlights:

- 01 A total of 55,000 plants have been planted and are currently being nurtured at three locations on the outskirts of Bengaluru, Karnataka.
- 02 The survival rate of the plants exceeds 98%.
- 03 Each year, approximately 13,75,000 kg of CO<sub>2</sub> is absorbed.
- 04 Approximately 64,90,000 kg of O<sub>2</sub> is produced annually.
- 05 Around 15,000 people—including commuters, school children, teachers, and caretakers—benefit daily from this initiative.

Puravankara has pledged to plant 1 million trees by 2030 as part of the World Economic Forum's "1 Trillion Trees" movement. Puravankara Ltd. is investing in the growth of 1 million native trees to supplement biodiversity and ecosystems by 2030. These trees are expected to sequester approximately 25,000 tons of carbon annually, supporting climate change mitigation. The initiative also benefits local communities through ecosystem benefits like pollination, water conservation and access to Non-Timber Forest Products (NTFPs).

### *From Saplings to a Self-Sustaining Forest*

*A compact plantation of native species grows together like a community, strengthening one another and restoring balance. In just a few years, it becomes a thriving ecosystem that cleans the air and supports life — naturally, rapidly, and sustainably.*

*It stands as a quiet reminder that even small spaces can grow into lasting green legacies.*

## Water Sustainability – Million Wells Program

As part of its commitment to environmental sustainability, Puravankara has partnered with Biome Environmental Trust to promote water conservation through the 'Million Wells Campaign' in Bengaluru. This initiative addresses water scarcity by rejuvenating wells and lakes and implementing rainwater harvesting systems. By restoring historic water sources and raising awareness on water conservation, the program improves local water access and supports long-term sustainability. These efforts reflect Puravankara's dedication to ensuring clean, safe water for communities while protecting the environment for future generations.

### Highlights:

01

A total of 12 wells and 1 Kalyani have been rejuvenated across various locations in Bengaluru: 6 in Hunsamaranahalli, 2 in Lalbagh, 1 at Rest House Park, 2 at Sonnapanahalli, 1 at DJ Halli, and 1 Kalyani in Hunsamaranahalli. These wells collectively provide approximately 93,000 KL of water each year.

02

9 recharge wells have been established in various locations throughout Bengaluru—2 at Rest House Park, 2 at Madiwala, 1 at Goa and 4 at ASC Centre—collectively recharging around 9,500 KL of groundwater annually.

03

Additionally, 6 rainwater harvesting systems have been installed: 1 each at Madiwala, Goa, and Sonnapanahalli and 3 at the ASC Centre in Bengaluru. These systems can harvest approximately 8,000 KL of water each year.

04

A total of 10 new filter borewells have been dug and 3 existing ones repaired in the Hunsamaranahalli area to enhance water supply from the shallow aquifer. Together, these borewells now provide approximately 468 KLD of water daily, benefiting around 5,000 residents.

04

Together, these initiatives benefit around 25,000 people.

### *From Water Scarcity to Groundwater Security*

*Innovative ideas help communities bring back water to their land, filling wells and restoring groundwater. As these solutions spread and fit local needs, they make life stronger and more secure — today and for the future.*



## Wells Tales....

Earlier, we faced severe water shortages for our daily needs. The water supply from the Town Municipal Council (TMC) was irregular and often delayed, as it came from deep bore wells that frequently had technical issues. Our situation improved greatly after the village's open well was rejuvenated, ensuring round-the-clock water availability for our household use. Later, a motor pump and a 2000-litres storage tank were installed, making it easier for us to collect water without long waits or struggles, even during peak hours. These efforts have made water more accessible and the process much more convenient for families like mine. I am deeply grateful for the much-needed and thoughtful water intervention in our community. - Rachamma, a resident of Sonnapanahalli village.





// The rejuvenation of the nearby well has made a big difference for us students. Earlier, we struggled with limited water for essential needs like washing our hands, cleaning our plates after meals, and using the washrooms. Now, with a steady water supply, we have access to clean water throughout the day—even for watering the plants—making our school environment much healthier and more comfortable. **Pooja, a Class-8 student of Sonnapanahalli Government School.** //

// Having a well near my home has made life much more convenient for me. I use the well water for all household chores except for drinking and cooking, just like others in my neighbourhood. Using a rope and pulley, I can easily draw water whenever I need it. To prevent wastage and to ensure we use water carefully, our community has also collectively decided not to install a motor pump for the well. – **Mrs. Poomani, a resident of Tamil colony, Hunsamaranahalli.** //

// I am very happy with the well restored by Puravankara. It has made my daily life much easier, as I no longer have to worry about water or wait for the supply. The water is clean and tastes good, and I use it for drinking, cooking, cleaning, and all my daily needs. – **Gautami, a 2nd PUC Student, Sonnapanahalli.** //

// Our area once struggled with water shortages and irregular supply, which made daily life difficult for everyone. Things have improved since Puravankara and Biome installed filter bore wells using shallow aquifers, which reduced the pressure on our deep wells. Now, people here have regular access to clean water at a low cost, making everyday life much easier for our community. – **Shashikumar, Waterman Supervisor, Hunasamaranahalli.** //

// With Puravankara's support and BIOME's intervention, 12 filter bore wells have been dug and 7 open wells were rejuvenated, tapping into shallow aquifers for a more reliable and cost-effective water supply. Residents are now receiving clean water consistently and have shared their gratitude, reflecting the positive impact this initiative has brought to our town. **Kantharaja, Chief Officer, Hunasamaranahalli TMC.** //

// North of Bangalore, under the Hunasamaranahalli TMC, the area faced challenges as repeated bore well drilling attempts failed. With support from Puravankara, Biome identified and revived six old heritage open wells, with the Mannu Vaddar team leading the desilting and cleaning work. These wells now provide 2–3 lakh litres of water daily to the TMC at just ₹1.38 per kilolitre. This solution is affordable, energy-efficient, and low in carbon emissions, improving climate resilience while ensuring a steady water supply for the community. – **S. Visvanath, Founder Trustee, Biome Environmental Trust.** //

## Education

Puravankara is committed to creating a positive social impact through targeted educational initiatives. Our efforts focus on three key areas: improving learning outcomes in government schools, ensuring equal opportunities for underprivileged students, and developing essential educational infrastructure. These initiatives include grooming programs for school children, scholarships for undergraduate students, and infrastructure support—each designed to empower socioeconomically disadvantaged youth and help them realise their full potential.

Below is an overview of our key initiatives:

### Khel Khel Mein

In partnership with the Wockhardt Foundation, Puravankara launched the “Khel Khel Mein” program to promote values and healthy habits among underprivileged children aged 6 to 12 from slum communities. The initiative uses play-based learning to teach human values, environmental awareness, and basic skills in English, math, and science. Celebrating key national and international days, the program also offers activities like dance, music, art, yoga, and non-fire cooking—fostering creativity, joy, and holistic development in a fun, engaging environment.

### Highlights:

- 01 Puravankara has established 7 Khel Khel Mein centres in Bangalore, Mumbai, and Pune.
- 02 Approximately 393 children have benefited from the program at these centres.
- 03 Over 150 activities are conducted each month across all centres.

### *Khel Khel Mein: Where Learning Feels Like Play*

*Khel Khel Mein (KKM) offers education that is more than school lessons. Children learn maths and science, and also values like empathy, respect, honesty, and responsibility through stories, games, and easy discussions.*

*The program supports children from underserved communities with regular study help and emotional care, helping them become confident and responsible.*

*KKM blends education with life skills and values to help children become confident, responsible citizens.*

## Vidyasaarathi Scholarship

Puravankara, in partnership with Protean eGov Technologies Limited (formerly NSDL eGovernance) and the Tata Institute of Social Sciences (TISS), is implementing the Vidyasaarathi Scholarship Program to promote equitable education. This initiative provides scholarships to undergraduate students from socio-economically disadvantaged backgrounds through the Vidyasaarathi platform—a digital tool by Protean eGov that connects deserving students with corporate-funded financial aid. Puravankara selects beneficiaries based on academic merit, local residency, and an annual family income below Rs. 5 lakhs. The program helps remove financial barriers, empowering students to pursue higher education.

### Highlights:

01

Under this program, 317 underprivileged students have received scholarships since 2019.

02

This program has been implemented for undergraduate students (B Tech, BCA, B-Com) in different colleges in Goa, Tamilnadu, Maharashtra and Karnataka.

## Special projects with the ‘Centre for Human Settlement, Anna University, Chennai’:

Puravankara has partnered with the Centre for Human Settlements at Anna University, Chennai, to support projects addressing urban flooding in a specific ward and to offer financial assistance to students enrolled in Plan-B courses at the university.

### A. Research on ward/neighborhood level water sensitive plan

A research project is being undertaken to prepare a ward/neighbourhood-level water-sensitive plan for an identified ward in Chennai. The city is grappling with water scarcity due to rapid urbanisation, excessive groundwater extraction, and the impacts of climate change. This comprehensive plan seeks to identify the specific needs and challenges of the area, ultimately offering innovative solutions to address these pressing water issues.

### B. Puravankara B-Plan endowment fund (Scholarship Program)

This program is designed to offer financial support to students from economically disadvantaged backgrounds. Under this initiative, Puravankara Ltd. will cover the semester and hostel fees for the entire four-year course for 10 B-Plan students. The students will be selected through a process overseen by a committee formed jointly by Anna University and Puravankara Ltd.



## Special initiatives for Youths

Puravankara is developing centers dedicated to value-based education and scientific learning to empower youth with modern knowledge and state-of-the-art facilities. These initiatives aim to foster personal growth and open doors to new opportunities. A summary of these efforts follows.

### Viveka Smaraka

The Viveka Smaraka Youth Centre provides values-based, character-building education inspired by Swami Vivekananda, benefiting thousands of students. This centre emphasises vocational skills, life skills, and cultural competence, fostering personality development and community engagement. Upon completion, it will annually impact around 25,000 students across 26 colleges and 582 schools and 5,000 urban and rural youth, including working professionals, homemakers, senior citizens, and tourists.

The centre will feature a 600-seat amphitheatre, a museum, an exhibition space, classrooms for short- and medium-term courses, a yoga and meditation hall, a bookstall, a library, study rooms, conference rooms, and counselling facilities.




## Project Param
